Subject: Cancellation of appointment/candidature of Mr. Zubair Farooq Bisati S/o Farooq Ahmad Bisati R/o Haft Chinar Srinagar for the post of Block Investigator (Industries and Commerce Department), Divisonal Cadre-Kashmir pursuant to advertisement Notification No. 06 of 2013 under Item No 301.

Whereas, Administrative Department vide letter No.IND/DIC-11/2012 dated 02.01.2018 forwarded select list as recommended by the Secretary, JKSSB vide letter No. SSB/Secy/Sel/251/2017/13119-25 dated 13.12.2017 for the post of Block Investigator (Industries and Commerce Department) Divisonal Cadre Kashmir pursuant to advertisement Notification No. 06 of 2013 under Item No 301 dated 10.05.2013 for issuance of appointment orders in favour of selected candidates after observing codal formalities.

Whereas, the Administrative Department vide letter No. IND/DIC-11/2012-I dated 28.11.2018 conveyed that the selection of Mr. Rouf Abdullah S/o Mohammad Abdullah R/o Darnambal Sopore Baramulla was cancelled by JKSSB vide order No 460-SSB of 2018 dated 25.10.2018 issued by Secretary, J&K Services Selection Board under endorsement No. SSB/Secy/Sel/251/2017/10830-32 dated 25.10.2018 and also directed to operate waiting list for filling up of the above vacancy of Block Investigator under OM category in the sequence of merit furnished by J&K SSB by giving first opportunity to Mr. Zubair Farooq Bisati.

Whereas, this office vide letter No.DI&C/Estt/C-76/4095-98 dated 29.11.2018 advised Mr. Zubair Farooq Bisati to submit all the requisite documents/certificates in original within a period of twenty-one (21) days from the date of issuance of this letter enabling us to proceed ahead in the matter. The said notice was sent to the candidate on the specified address through registered post. Besides floated in the local daily newspaper NIDA-I-MASHRIQ through information department and also uploaded on the official website of this Directorate for information of the candidate.

Whereas, the candidate did not responded to the said notice.

Whereas, after lapse of 22 days from the date of notice dated 29-11-2018, this office vide letter No. DI&C/Estt/C-76/2603-06 dated 21.12.2018 again advised Mr. Zubair Farooq Bisati to submit all the requisite documents/certificates within a period of seven (7) days. The notice was sent to him through registered post and also published in newspapers namely The Rising Kashmir, Srinagar Times, Imroze Kashmir dated 24-12-2018. But, the candidate did not responded in the matter.

Whereas, despite lapse of 13 days from date of issuance of aforementioned letter dated 21.12.2018, this office vide letter No. DI&C/Estt/C-76(I)/2696-99 dated 02.01.2019 gave a last and final notice to the candidate for submitting the requisite documents within specified time of further seven (7) days and with the stipulation that failing in submission of requisite documents/certificates shall presume that you are not


interested to take up the job for which you have been selected and cancellation of your candidature/appointment for the captioned post in this Directorate shall follow. The final notice was also sent to him through registered post and was floated in the daily newspapers The Mirror Of Kashmir & The Daily Aftab Srinagar dated 04.01.2019.

Whereas, the candidate again failed to submit his documents neither approached this office in any manner even after lapse of 11 days.

Whereas, it is apparent from above that Mr. Zubair Farooq Bisati S/o Farooq Ahmad Bisati R/o Haft Chinar Srinagar was given ample opportunity of 45 days from date of issuance of 1st notice dated 29.11.2018 and has failed to submit the requisite documents which would have enabled us to issue appointment order.

Whereas, the failure from the candidate to submit the documents/certificates clearly indicates that he is not interested to take up the job for which he has been selected.

In view of facts and circumstances narrated herein above, it is hereby ordered that the candidature/appointment of Mr. Zubair Farooq Bisati S/o Farooq Ahmad Bisati R/o Haft Chinar Srinagar for the post of Block Investigator in the Directorate of Industries and Commerce Kashmir pursuant to advertisement Notification No. 06 of 2013 under Item No 301 stands cancelled ab-initio.
