Sub: Promotion of Mr. Ghulam Hassan Itoo, Junior Assistant as Senior Assistant- speaking order thereof in light of the minutes of the Divisional Level Departmental Promotion Committee meeting held on 28.07.2018.

Whereas, final seniority list of Junior Assistant as it stood on 01.02.2018 was issued by this Directorate vide notification No. 01 E of 2018 dated 05.02.2018 issued under endorsement No. DI&C/Est/C-183/3448-65 dated 05.02.2018.

Whereas, Mr. Abdul Gani Mir, Jr. Assistant submitted an affidavit in this office dated 27.01.2017 duly attested by the Sub-Judge, Judicial Magistrate 1st Class Kupwara, inter-alia stating therein that he doesn't want promotion due to health problems (heart ailment). He has also stated that he will not claim for the promotion in future.

Whereas, during the Divisional Level Departmental Promotion Committee meeting which met under the chairmanship of Director Industries & Commerce Kashmir on 24.04.2018, among others, granted regular promotion of several Junior Assistants as Senior Assistants figuring in the aforementioned final seniority list of Junior Assistants from S.No.01 to 10 excluding one Jr. Assistant namely Abdul Gani Mir figuring at S.No. 08.

Whereas, during the said DPC, the request of Mr. Abdul Gani Mir, Jr. Assistant was discussed thread bare and his promotion as Sr. Assistant was deferred due to non-availability of APRs, Integrity Certificate etc. Moreover, one post of Senior Assistant was kept reserved for promotion of the said official.

Whereas, Mr. Abdul Gani Mir, Jr. Assistant again submitted an affidavit dated 09.05.2018 duly attested by the Addl. Special Mobile Magistrate, Kralpora Kupwara, inter-alia, stating that;

2. ***The department is going to give me promotion but the deponents do not want promotion due to health problem, I am a heart patient.***
3. ***The deponent declares on oath that I will not claim later for promotion to the department. I on my own choice do not want promotion; I will work as Jr.Assistant in the department."***


Whereas, the case was again placed before the Divisional Level Departmental Promotion Committee meeting which met on 28.07.2018 and the request for forgoing of promotion of Mr. Abdul Gani Mir, Jr. Assistant was accepted in view of the aforementioned affidavits submitted by him and the post reserved earlier for Mr. Abdul Gani Mir was decided to be utilized for the promotion of the next eligible senior most Junior Assistant.

Whereas, the DPC meeting dated 28.07.2018, found that Mr. Gh. Hassan Itoo falling at S.No. 11 of the final seniority list of Junior Assistants is the next official to be considered for promotion and cleared his promotion as Senior Assistant w.e.f 28.07.2018 on the post, the promotion on which has been forgone by Mr. Abdul Gani Mir, Jr. Assistant.

In view of above facts and in light of the minutes of the Divisional Level Departmental Promotion Committee meeting held on 28.07.2018, the request of Mr. Abdul Gani Mir, Jr. Assistant regarding foregoing his promotion as Sr. Assistant is hereby accepted and accordingly, sanction is hereby accorded to the promotion of Mr. Ghulam Hassan Itoo as Senior Assistant in the pay band/ grade pay of Rs.5200-20200 plus GP Rs 2400 (Pre-revised) retrospectively w.e.f 28.07.2018.

The above promotion shall be subject to the outcome of writ petition(s), if any, pending in the competent court of law.

Consequent upon above, Mr. Gh. Hassan Itoo shall continue to work at DIC Baramulla against the available post of Senior Assistant.


