Subject: **Opening of Offices in the Union Territory of Jammu and Kashmir.**

**Government Order No.477-JK(GAD) of 2020**

**Dated:17.04.2020**


In pursuance to order No. 40-3/2020-DM-I(A) dated 15<sup>th</sup> April, 2020 issued by the Union Home Secretary in terms of Section 10(2)(1) of the Disaster Management Act, 2005 and in partial modification of Government Order No. 421-JK(GAD) of 2020 dated 25.03.2020 read with Government Order No. 472-JK(GAD) of 2020 dated 15.04.2020, it is hereby ordered that the Government offices in the Union Territory of Jammu & Kashmir shall resume their working in the following manner w.e.f. 20.04.2020:-

- (A) All the offices dealing with essential supplies/services shall be fully functional as already instructed in the referred Government orders;
- (B) All the Educational Institutions/Training Institutes shall remain closed till 3<sup>rd</sup> May, 2020;
- (C) In all other offices:-
  - i) Officers of the level of Under Secretary and above shall regularly attend offices w.e.f 20.04.2020;
  - ii) 33% of Non-Gazetted staff shall attend office as per roster to be devised by the respective Head of offices;
- (D) Staff/workers of Forest Department operating and maintaining zoo, nurseries, wildlife, fire-fighting in forests, watering plantations and patrolling shall work as usual.

The Head of offices shall take necessary steps for implementation of instructions with regard to social distancing, face masks and sanitizing the work places in their respective Offices, as per guidelines.

Arrangements for issuance of passes shall be made by the General Administration Department for Civil Secretariat Employees and by the Deputy Commissioners in respect of officers/officials working in their respective jurisdictions.


