- 3. The appointees shall be on probation for a period two years and the appointment(s) shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24-12-2009;
- 4. In case, at any stage, any candidate is adversely reported upon by the verifying agency or any certificate is found not to be genuine/valid, he/she shall have no claim to hold the post to which appointed and his/her appointment shall automatically stand cancelled ab-initio without any further notice;
- 5.
