WHEREAS, a Tentative Seniority List of IPOs, appointed to the Service w.e.f 06.01.2018 to 31.12.2023, was issued vide Notification No. 01-DI&C/ E of 2024 dated 09.01.2024 for inviting objections, if any, from the officials, to the inter-se-seniority position assigned to them in the said Seniority list, within a period of 10 days from the date of issuance of Tentative Seniority list; and

- WHEREAS, in pursuance of the above, 10 (ten) representations were received from various officials within the stipulated time which have been examined; and
- WHEREAS, before examining these representations it was considered appropriate to afford an opportunity of being heard to these representees. Accordingly, personal hearing, on 30<sup>th</sup> January, 2024, was given to them and their contentions were taken note of; and
- WHEREAS, the officials in their representations have mainly raised the following 4. issues:
  - Clubbing of merit of candidates figuring in the 02 Selection Lists pertaining to Notification year(s) 2013 and 2014, and finalization of seniority list accordingly. *(i)*
  - Incorporation of the status to the effect of belonging to a particular category i.e. RBA, OSC etc., notwithstanding expiry of the validity period of the certificates (ii) earlier obtained, on the plea that the applications have been filed before the Competent authority for re-issuance of these certificates.
  - Restoration of inter-se seniority position as per the position assigned to (iii) Mr. Mansoor Ahmad Bhat, IPO in the final seniority list, as it stood on 01.07.2021.

WHEREAS, while the rest of the issues viz. (i) and (ii) of the para 04 above, 5. highlighted in the representations, have been duly considered and examined with reference to the relevant records and rule position governing the subject and found to be devoid of merit and hence rejected, with regard to the issue relating to restoration of inter-se-seniority position assigned to Mr. Mansoor Ahmad Bhat, IPO, as indicated at (iii) of para 04 above, the claim after being examined in light of the relevant records and rule position governing the subject and past precedence, as also based on the treatment meted out to the similarly circumstanced candidates by other departments has been found to be genuine, warranting rectification of the inter-se seniority position assigned to him, which shall be above Mr. Qayoom Sidique Bahar, IPO and below Mr. Saleem Yousuf Mir, IPO and for this purpose notional effect is hereby granted to his appointment w.e.f 06.01.2018 i.e. the date of appointment of his immediate junior namely Mr. Qayoom Sidique Bahar, IPO. This shall be merely for purposes of seniority without payment of arrears. The details are brought out in Annexure A to this Order.

Now, therefore, the Final Seniority List of the members of the Jammu and Kashmir Industries & Commerce Subordinate Service [Industrial Promotion Officers (IPOs)] appointed w.e.f 06.01.2018 to 31.12.2023, as it stood on 01.01.2024, forming Annexure B to this Order, is hereby notified and circulated for information of the concerned members of the service, which shall be subject to the condition that:

(a) the inter-se-seniority position of the members of the service shall be without prejudice to the outcome of the writ petition(s) pending in any Competent Court(s) of Law; and

(b) the date(s) of birth reflected in the Seniority List shall in no manner be construed at final and shall be subject to the entries recorded in the individual Service Books/ Date of Birth Certificates, issued by the Competent Authority.

Position 32) in the tentative seniority list objected to the <i>inter-se-seniority</i> position assigned to them in the Tentative Seniority on the plea that the <i>inter-se seniority</i> of officials (direct recruits) may be finalized as per the merit secured/ obtained by them and in accordance with the principles laid down by the Hon'ble High Court in the Case titled Mr. Saqib Saleem and Others V/s State of J&K and others, vide judgment dated 26.12.2023.
		Although, the issue stands already rejected by the Directorate of I&C, Kashmir earlier, while finalizing of the seniority list of IPOs, at it stood on 01.07.2021, issued vide Notification No. 08 DI&C/ E of 2021 dated 17.11.2021, yet the matter has been reconsidered and found to be devoid of merit. As regards adoption of the principles laid down in the judgement dated 26.12.2023 in the case titled titled Mr. Saqib Saleem and Others V/s State of J&K and others, the facts and circumstances of that case are different from the issue in hand and as such, the case not being analogous does not invite application of the principle in the instant case.
		Therefore, the seniority position have been assigned on the basis of the merit furnished by the JK SSB with due deference to the dates of advertisement of posts & selection lists received from J&K SSB & Administrative Department.
