Whereas, the tentative seniority list of Block Investigators of Directorate of Industries and Commerce (Division Kashmir) as it stood on 01.05.2023 was notified vide this office notification No; 39 DI&C of 2023 dt 08.05.2023 , issued under endorsement No:- DI&C/Estt/C-244II/1322-36 Dt:- 08.05.2023 seeking objections, if any, from concerend within a period of (21) twenty one days.

Whereas, this office received representation from Mr. Taseen Ali, Block Investigator expressing objection regarding promotion of Ms. Shagufta Fatima, Knitting Instructor as Block Investigator and assignment of her seniority above other Block Investigators.

Whereas, the matter has been considered and it has been found that the Department has proceeded under rules while finalization of promotion case of Ms. Shagufta Fatima as well as the applicant by the Divisional Level Departmental Promotion Committee which met on 09.05.2022. As per the said draft recruitment rules (dated 2012) which are operational in the Department, the mode of recruitment for the post of Block Investigator is given hereunder:

- a) 50% by direct recruitment.
- b) 50% from Assistant Extension Officer, Instructor Calico Printing and Instructor Knitting who should at least be graduate with three (03) years service in that category.

Ms. Shagufta Fatima was appointed as Knitting Instructor on 08.04.2017 possessing qualification as graduation, makes her eligible for promotion against the post of Block Investigator in light of rule position ibid. Therefore, the DPC proceeded under rules while securitizing promotions in the category. It is pertinent to mention here that these rules regulate both direct recruitment as well as promotions in the Department and all these officials were initially appointed in the Department on the basis of aforementioned recruitment rules also.

Whereas, the Seniority of the Ms. Shagufta Fatima, Block Investigator (S.No. 01) has been reckoned in view of the length of the service put in by her in the feeding cadre (i,e Knitting Instructor) and rest of the officials (S.No 02 to 08) were appointed on later dates as Assistant Extension Officers during the year 2018 as per the merit furnished by J&K SSB. Therefore, seniority positions of these officials have been assigned keeping in view of relative length of service of these officials in the feeding service viz Knitting Instructor, AEO/ Manager IEs as the case may be.

Now in view of above, the claim/ objection of Mr. Taseen Ali, BI has been considered and found devoid of any merit and hence rejected. The final seniority list of Block Investigators borne on the establishment of this Directorate (Division Kashmir) as it stood on 01.06.2023 is hereby notified as Annexure "A" for information of all the concerned officials. The final seniority list shall be without prejudice to the final outcome of the writ petition(s) if any, pending before the competent court of law.

Moreover, the date of birth, category status of the listed officials shall not be taken as authentic and shall be subject to further verification from the service book/Date of Birth certificate (Matriculation certificate), valid category certificate (as the case may be) issued in respect of the officials by the competent authorities.
