Subject: Ranking of Hospital projects having bed capacity of less than 200 beds and Nursing College/ Training Institute projects received on the online portal for allotment of land in Kashmir Division at IE Lelhar, Pulwama.

Public Notice

Government of J&K vide Order No. 46-JK (IND) of 2021 dated 26.07.2021 declared Industrial Estate, Lelhar Pulwama as Medi-city. Accordingly, ranking list of Hospital projects having bed capacity of less than 200 beds and Nursing College/ Training Institute projects received for Medicity on the online portal was prepared on the basis of merit cum choice mechanism devised by the HLLAC in its 3rd and 5th meeting respectively and the same was placed before the 8th High Level Land Allotment Committee meeting held on 09.04.2022 for discussion/ decision in view of the transfer of above mentioned new patch of land. The committee after threadbare discussion decided to consider all these projects for allotment of land in the IE, Lelhar Pulwama strictly as per the merit cum choice mechanism.

The allotment of land in Medicity, is however subject to fulfillment of following conditions:

- 1. Land in the locations identified for establishment of Hospital and allied facilities shall be allotted only to Hospitals, Hospital cum Medical Colleges and Nursing College/ Training Institutes.
- The project proponents shall furnish an undertaking in the shape of affidavit duly attested by Judicial Magistrate before issuance of allotment letter regarding fulfillment of 85% of the commitments as per the appraised DPR.
- 3. The mandate of High Level Land Allotment Committee is related to allotment of land only, however the permission related to medical colleges/ hospitals shall be granted by the Health & Medical Education Department as per their norms/regulations and other relevant norms. In case the applicant fails to qualify the norms, land allotted shall be treated as cancelled ab-initio.

In this context, it is for the information of general public and applicants that the ranking of Hospital projects having bed capacity of less than 200 beds and Nursing College/ Training Institute projects received on the online portal for allotment of land is now available on the official web sites of Directorate of Industries and Commerce, Kashmir (www.industrieskashmir.nic.in) and on other online portals of I&C and J&K SICOP/ J&K SIDCO and is annexed as Annexure-A and Annexure-B respectively to this notice.

In the backdrop of herein above, the applicants figuring in the ranking list are advised to go through the ranking list and check their project profile/ merit score and bring any variance/ discrepancy to the notice of General Manager, DIC, Srinagar within a period of 03 days failing which no claim shall be entertained after expiry of the said period.
