ORDER No. 04 DI&C/E of 2018 DATED 06.01.2018

As recommended by the J&K Services Selection Board and Administrative Department vide above referred communications, sanction is hereby accorded to the appointment of 06 (Six) candidates, details given in annexure A to this order, to the post of Assistant Extension Officer/ Manager, Rural Industries (Divisional Cadre-Kashmir) on temporary basis in the pay scale of Rs.9300-34800/- with Grade Pay Rs.4200/- plus other allowances as admissible under rules in the Directorate of Industries & Commerce, Kashmir.

The appointees shall report to the office of General Manager, District Industries Centres shown against each in the above-mentioned annexure within a period of 21 days from the date of issuance of this order. The General Manager DIC concerned shall allow appointee to join only on the production of the following documents/ certificates, in original, to be verified subsequently:

- 1. Academic/ Technical Qualification Certificates.
- 2. Date of birth Certificate.
- 3. Health certificate issued by the competent authority.
- 4. Permanent Resident Certificate.
- 5. Certificate from the General Manager DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any scheme.
- 6. Reservation/ Category Certificate, if any, issued by competent authority.
- 7. Undertaking in the shape of an affidavit duly attested by the Judicial Magistrate, to the effect that:
 - a) In case, adverse report about his/ her character and antecedents is received from Inspector General of Police CID J&K to whom a reference shall be made by the concerned Department/ DIC, his/ her appointment shall be deemed to be cancelled ab-initio and he/she shall have no claim on his/her appointment and.







b) In case, at any time, if it emerges that the documents/ Academic/ Technical / other certificates (including of recognition of institutes) furnished by them are proved fake/forged, the appointment as shall be cancelled ab-initio and he/she have no claim on his/ her appointment.

The salary of the appointees shall be drawn and disbursed unless a satisfactory report in respect of point 7 (a) and (b) above is received by the concerned DIC, for which GM DIC concerned shall take matter with concerned authorities.

The General Manager DIC concerned shall crosscheck/verify the particulars of the appointees as provided in the above mentioned selection list of J&K SSB, copies enclosed, with certificates of appointees before allowing them to join.

This appointment order shall, however, be subject to outcome of writ petition, if any, pending in any court of law.

The Appointees shall be on probation for a period of 02 (two years) from the date of their joining and their seniority shall be determined by the standing guidelines/ rules in vogue.
