## Order No. 179 DI&C/E of 2018 Dated: 21.10.2018

As recommended by the J&K Services Selection Board duly endorsed by the Administrative Department (Industries and Commerce Department) vide above referred letters sanction is hereby accorded to the appointment of Munesh Kumar S/o Pritam Chand R/o Budhi Kathua for the post of Junior Assistant on temporary basis in the pay scale of Rs.5200-20200/- with Grade Pay Rs.1900/-(pre-revised) in the Directorate of Industries & Commerce Kashmir under SC category.

The appointee shall however be on probation for a period of 05 years. During the period he shall be entitled to draw pay in terms of J&K Special Recruitment Rules 2015 notified vide SRO 202 of 2015 dated 30.06.2015 & shall be entitled for fixation of pay in the time scale of pay applicable to the post after completion of 05 years of satisfactory service.

The appointee shall report to the office of General Manager, District Industries Centre Budgam within a period of 21 days from the date of issuance of this order, failing which, it shall be presumed that appointee is not interested to take up the job for which he has been selected and the appointment, as such, shall be deemed to be cancelled without further notice/ correspondence. The General Manager DIC Budgam shall allow appointee to join only on the production of the following documents/ certificates, in original, to be verified subsequently:

- 1. Academic/ Technical Qualification Certificates.
- 2. Health certificate from the Chief Medical Officer of the concerned District.
- 3. Date of birth Certificate/ Matriculation.
- 4. Permanent Resident Certificate issued by the competent authority.
- 5. NOC or Certificate from the General Manager DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any scheme.
- 6 Valid Reservation/ Category Certificate issued by competent authority.

The appointment of the above candidate as Junior Assistant in this Directorate shall further be subject to the following conditions that;

i) The appointee shall give an undertaking in the shape of an affidavit duly attested by the Judicial Magistrate, to the effect that in case any adverse report about his character and antecedents is received from Additional Director

General of Police CID J&K, to whom a reference shall be made by the concerned DIC, his appointment as Junior Assistant in this Directorate shall be deemed to have been cancelled ab-initio.

ii) Verification/genuineness of the qualification, reserved category certificates (wherever applicable) and recognition of the Institutes from the concerned

issuing authorities.

The salary of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of point (i) and (ii) above is received by the concerned DIC, for which GM DIC shall take matter with concerned authorities.

The General Manager DIC shall also crosscheck/ verify the particulars of the appointee as provided in the above mentioned selection list of J&K SSB, copies enclosed, with certificates of appointee before allowing him to join.

This appointment order shall, however, be subject to outcome of writ petition, if

any, pending in any court of law.

The seniority of the appointee shall be determined by the standing guidelines/ rules in vogue.
