Whereas, the Administrative Department vide letter No. IND/DIC-11/2012 dated 02.01.2018, among others, forwarded selection lists of candidates for the post of Block Investigators as recommended by the J&K Services Selection Board vide No. JK SBB/ Secy/ Sel/2017/13119 -25 dt 13.12.2017. The said communication of J&K Services Selection Board forwarded separate selection list of candidates for the post of Block Investigators forming its Annexures. The J&K SSB had clearly outlined that selection panel in these Annexures correspond to the posts of Block Investigator referred against the indent No. IND/,DIC-II/ 2012 dated 18.03.2013/ advertised under notification no. 06 of 2013 (item no. 301) and the indent No. IND/ DIC-11/2012 dated 31.12.2013/ advertised under notification no. 01 of 2014 (item no. 021).

Whereas, the appointment of the selected candidates (except those withheld recommendations) was carried out by the Directorate vide Order No. 05 DI&C/ E of 2018 dated 06.01.2018 allotting the inter-se position of the appointee in the appointment order strictly as per the merit furnished by the J&K SSB.

Whereas, the Administrative Department vide letter No. Admn letter: IND/DIC-11/2012 dt 16.01.2018, released withheld recommendations of more Block Investigators on the recommendations of J&K SSB vide No. SSB/ Secy/ Sel/ 251/ 2017/ 413-15 dated 08.01.2018. The selected candidates were appointed vide Directorate's order No. Order No. 15 DI&C/E of 2018 dated 22.01.2018.

Whereas, the Directorate received resignations from the following three Block Investigators, which were subsequently accepted by the Directorate under relevant provisions of law as per details given hereunder:

Whereas, one Ms. Kunzang Dolma, Block Investigator belonging to Ladakh Division had opted for UT Ladakh service while exercising option consequent upon enactment of J&K Reorganization Act 2019 & creation of separate Directorate of Industries & Commerce, Ladakh. As such, she has to be excluded from the list.

In view of the facts recorded hereinabove, the draft seniority list of Block Investigators, Division Kashmir, borne on the establishment of Directorate of Industries and Commerce

Kashmir as it stood on 01.07.2020 has been prepared in terms of Rule 24 of J&K Civil Service (Classification, Control & Appeal) Rules, 1956 with due regard to the requisition vis-à-vis corresponding merit/ selection list received from the J&K SSB, is hereby notified as **Annexure A** to this notification for the information of all the concerned officials.

Concerned official (s) having any objection(s) as regards his/ her seniority, Date of Birth, Date of Entry in the Govt. Service or placement in the present grade, name etc in the said tentative list, he/ she shall file his/ her objection(s) to this Directorate through concerned DDO within fifteen days from the date of issue of this notification.

Moreover, the concerned DDOs shall also check /verify aforementioned particulars as per the Service Book/ relevant records of concerned officials and convey necessary rectifications, if any required.

In case no objection is received within stipulated time, it shall be presumed that official(s) do not have any objection(s) to his/ her seniority as well as particulars as indicated in the said annexure. Accordingly, the seniority list of Block Investigators of this Directorate for the year 2020 shall be finalized & issued.
