Subject: Cancellation of appointment of Mr. Muneer Ahmad Dar S/o Abdul Gaffar Dar R/o Panzan Chadoora Budgam (RBA) for the post of the "Junior Assistant" (Industries and Commerce Department) Division Cadre Kashmir, Item No. 024 (01 of 2014 dated 13.08.2014 in the Directorate of Industries and Commerce Kashmir.

Whereas, Administrative Department vide letter No IND/DIC-11/2012 dated 08-08-2018 forwarded select list as recommended by the Secretary, JKSSB vide letter No. SSB/ Secy/ Sel/ 2018/ 7730-36 dated 06-07-2018 for the post of the "Junior Assistant" (Industries and Commerce Department) Division Cadre Kashmir, Item No. 024 (01 of 2014 dated 13.08.2014.

Whereas, among other selected candidates figuring under various categories, Mr. Muneer Ahmad Dar S/o Abdul Gaffar Dar R/o Panzan Chadoora Budgam figured at S.No 01 under RBA category in the said select list.

Whereas, this office order No. 157-DI&C/E of 2018 dated 04-09-2018 issued under endorsement No. DI&C/Estt/C-76/1983-94 dated 04-09-2018 issued appointment order in favour of three candidates including the aforementioned candidate after checking all requisite documents, in original, as furnished by him.

Whereas, in the said appointment order, Mr. Muneer Ahmad Dar S/o Abdul Gaffar Dar R/o Panzan Chadoora Budgam was directed to report to the office of General Manager, District Industries Centre Shopian within a period of 21 days failing which, it shall be presumed that he is not interested to take up the job for which he has been selected and the appointment shall be cancelled without further notice/correspondence. The said appointment order was forwarded to all the selected candidates including Mr. Muneer Ahmad Dar S/o Abdul Gaffar Dar R/o Panzan Chadoora Budgam to his specified addresses.

Whereas, after the lapse of more than 45 days, the General Manager, District Industries Centre Shopian vide letter No DICS/Estt/18/413 dated 26-10-2018 reported that the said candidate has not joined office till date.

Whereas, Mr. Muneer Ahmad Dar S/o Abdul Gaffar Dar R/o Panzan Chadoora Budgam vide this office letter No. DI&C/Estt/C-76/ 2897-2901 dated 30-10-2018 was afforded a final opportunity to report to the office of General Manager, District Industries Centre Shopian within a weeks time from the date of issuance of the letter, failing which the appointment shall be cancelled without any further notice/correspondence. The said notice was forwarded to the candidate to his specified address through speed post, published in the daily newspaper Srinagar Times dated 03-11-2018 and uploaded on the notice board of the official website of the Directorate as well.

Whereas, after 15 days the General Manager, District Industries Centre Shopian vide letter No DICS/Estt/18/560 dated 15-11-2018 has reported that the said candidate has not reported to the DIC till date.

Whereas, it is apparent from above that after the lapse of 73 days from the date of issuance of the appointment order, the candidate has failed to join the government service for the post of Junior Assistant in the Directorate of Industries and Commerce Kashmir which clearly indicates that he is not interested to take up the job for which he has been appointed.


