Whereas, one official namely Mr. Abdul Rashid Sheikh was granted regular promotion as Head Assistant w.e.f 09.03.2013 vide this Directorate's order No. 58 E of 2015 dated 29.06.2015.

Whereas, the official was granted regular promotion as Section Officer w.e.f 05.03.2016 vide this Directorate's order No. 86 E of 2016 dated 05.10.2016.

Whereas, relevant details of the various Section Officers including Mr. Abdul Rashid Sheikh Section officer were forwarded to General Administration Department vide letter No. Estt/ 593/ 717 dated 13.05.2017 for their inclusion in the seniority list of Section Officers.

Whereas, in response to aforementioned communication, the Under Secretary to Govt., General Administration Department vide letter No. GAD (Estt) M-16/2009-I dated 25.10.2017 informed that it has been observed from the service book of the official that he has been promoted as Head Assistant w.e.f 09.03.2013 and subsequently promoted as Section Officer w.e.f 05.03.2016 which indicates shortfall of 04 days in completion of prescribed period of his eligibility i.e. three years, as per recruitment rules.

Whereas, the case of the official was minutely discussed in the Divisional Level Departmental Promotion Committee meeting which met under the Chairmanship of Director I&C Kashmir on 24.04.2018.

Whereas, the DPC was of the opinion that the Directorate's order No. 86 E of 2016 dated 05.10.2016 be modified considering the promotion of the official as Section Officer w.e.f 09.03.2016 instead of 05.03.2016 and the salary of 04 days may be recovered from him.

In view of above, it is hereby ordered that the promotion of Mr. Abdul Rashid Sheikh as Section Officer shall deemed to be considered from 09.03.2016 instead of 05.03.2016 which may be treated as necessary modification to this Directorate's order No. 86 E of 2016 dated 05.10.2016. The General Manager, DIC Paramolla shall recover 04 days salary (i.e w.e.f 05.03.2016 to 08.03.2016) from the official immediately and make necessary entries in the service book of the official.
