On the recommendations of the Committee constituted vide order No. 87 DI&C /E of 2018 dated 26.05.2018 issued under endorsement No. DI&C/Estt/ C-183/591-96 dated 26.05.2018 for conducting typing test of the eligible Class IV officials recommended by all our sub offices, following officials who have qualified the said test as per the prescribed criteria, are hereby temporarily promoted as Junior Assistants in their own pay and grade, for a period of 06 months or till clearance of the Departmental Promotion Committee (DPC) whichever is earlier. The charge allowance as admissible under rules is also sanctioned in their favour from the date they formally assume the charge of the post:
